Spearfish Economic Development Corporation (SEDC) and the South Dakota Governor's Office of Economic Development (GOED) recently teamed up to host several Small Group Retention and Expansion (R&E) Zoom meetings with dozens of Spearfish businesses.

Discussion topics included the impact of the COVID-19 situation on individual businesses and industry sectors in general, solutions and adaptations implemented by the Spearfish business community, and the variety of financial relief programs made available during the pandemic. Industry groups ranged from coffee shops and restaurants to manufacturing and construction services.

"The goal of these conversations was to answer questions, help find solutions, and gather input on how we can serve the local business community even better moving forward," explained Cayley Schmitt, SEDC Marketing & Administrative Coordinator. "We sincerely appreciate the excellent feedback we received from our local businesses. It was also wonderful the way the participants were able to exchange strategies and ideas amongst themselves."

South Dakota Lenders Have Approved \$1.6 Billion in Paycheck Protection Program Loans



Eighteen years' worth of small business loans were approved over nine weeks in South Dakota as the COVID-19 pandemic has affected business, the U.S. Small Business Administration (SBA) South Dakota District Office said Wednesday. South Dakota lenders have approved 21,154 Paycheck Protection Program (PPP) loans totaling over \$1.6 billion throughout the state.

The PPP was created by the CARES Act and began approving forgivable loans on April 3 to small businesses affected by the pandemic to keep their employees on the payroll and help cover specific operational costs. This volume of loan approvals equates to 18 years of annual SBA loan approvals in South Dakota that would have been made in normal circumstances.

Last fiscal year, South Dakota lenders made about \$90 million in SBA guaranteed loans. Hundreds of lenders continue to participate in the response effort by directly facilitating the SBA PPP loans, to get survival capital into the hands of business owners quickly.

Currently, PPP loans remain available to South Dakota's small businesses through local community lenders until June 30.

A Message from SEDC Director Kory Menken: Small Business is the Backbone of our Economy

The U.S. Small Business Administration's (SBA) Office of Advocacy recently released their 2020 version of Small Business Profiles for all states and territories. Each year, the



Office of Advocacy's economic research team gathers the most up-to-date government economic data to construct a comprehensive snapshot of each state's small business employment, industry, and economic growth statistics.


I am pleased to report the 2020 South Dakota Profile concludes that the number of small businesses increased to 88,191, up 1641 businesses from the 2019 report. These South Dakota small businesses provide 209,403 jobs - including 58.2% of the private workforce- across the state. Additionally, the number of South Dakota small businesses involved in exporting increased from 669 to 703.

According to the report, the industries in South Dakota with the most small businesses are:

- 1. Health care and social assistance
- 2. Accommodation and food services
- 3. Retail trade

It is important to note the 2020 Small Business Profiles largely showcase economic information collected before the COVID-19 pandemic. The profile shows in 2019, prior to the pandemic, small businesses created 2,082 net new jobs in South Dakota. In April 2020, the unemployment rate was 10.2%, up from 3.2% just a year earlier.

Growing up in a small business family, I observed first-hand both the risks and rewards of entrepreneurship. SEDC applauds our local small business owners and operators, as they are the backbone of our economy and the cornerstones of our community.
